IMPORTANT TERMS AND CONDITIONS

TIME LIMITS

The candidate has one year from the date of application to complete the full examination. Written and practical examinations are only valid for one year from the date of the examination.

NOTIFICATION OF RESULTS

The examiner will recommend a pass or a fail. The Chairman of the Offshore Committee is entitled to request re-examination.

BOOKING OF EXAMINATIONS

Unless it is an end of course examination arranged by a South African Sailing (SAS) approved school, all examinations must be booked through a SAS Regional office. This office will be responsible for appointing an examiner. Any exam booked by a candidate directly with an examiner will be deemed to be invalid.

GENERAL INFORMATION

EXAMINATION FEES

The examination fees are listed on the SAS website. The application form will not be processed until the examination fee has been paid. Should you wish to deposit the money directly into the SAS account you are welcome to do so.

To qualify for the SAS member's discount, you must be registered on the SAS database as a paid-up member of SAS.

SUPPORTING DOCUMENTATION

The following documentation will be required to process your application. We would prefer you to submit all documentation including the photograph electronically.

1. Proof of payment
2. A clearly recognisable copy of your SA ID Document or your foreign passport
3. Identification colour photograph
4. Copy of your SAS or SAMSA eye test
5. Copy of your log book with subtotals on each page carried forward correctly.
6. Copy of your VHF operator's certificate.
7. A copy of your first aid certificate.

If you do not yet have some of these pre-requisites, you may submit an initial application which must include items 1 to 4. Where possible, please submit the application and the supporting documents electronically by email.

EYE TEST

The eye test must be completed by a registered optician using the SAS form that can be downloaded from the "Prerequisites" page. Most opticians will not charge for the service. SAMSA have ruled that colour-blind candidates may not qualify beyond Day Skipper as they consider colour vision to be essential for night sailing.

A SAMSA eye test is also accepted.

QUALIFYING MILES, NIGHT HOURS AND PASSAGES

Qualifying miles are the total nautical miles logged on a sailing vessel at sea as skipper or as an active member of crew. Qualifying night hours are those hours spent on watch at night from sunset to sunrise on a sailing vessel at sea. Qualifying passages are passages of 60 nautical miles or more on a sailing vessel at sea.

CHARTWORK EXAMINATION REQUIREMENTS

The following will be required for your chartwork examination:

1. Chart 3002 unused.
2. Portland plotter, dividers, soft pencil and soft rubber.
3. An examination pad (square paper is useful for interpolation) and a pen.
4. Calculator with a square root button.

All chartwork must be completed in pencil but all workings and answers on the answer sheet must be completed in pen. Mobile phones, tablets, laptop computers, cameras and other electronic storage devices may not be brought into the exam room.

PRACTICAL EXAMINATION FOR EXAMS NOT CONDUCTED THROUGH A SAS SAILING SCHOOL

It is the candidate's responsibility to provide a yacht and crew for the practical exam. SAS will appoint an examiner. It is the candidate's responsibility to contact the examiner to make an arrangement for the exam. If the weather is not suitable the examiner may decide to postpone the exam.
